

TORQUAY VILLAGE BECAUSE SHE DESERVES IT MOTHERS DAY GIVEAWAY

1. Information on how to enter and prizes form part of these Terms & Conditions. Participation in this Torquay Village Because she deserves it Mother's Day Giveaway ("Competition") is deemed acceptance of these Terms & Conditions.
2. This competition is only available at Torquay Village, 41 Bristol Rd, Torquay 3228.

ELIGIBILITY

3. Subject to condition 4, this Promotion is open to all Torquay Village shoppers. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all Terms & Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
4. PROMOTION PERIOD

Prize draws will take place at 9.00am on Friday 9th May 2025 by Centre Management. Two winners will be chosen and winners will be drawn by random computerized draw.

HOW TO ENTER

6. To enter this Promotion, eligible individuals must make a \$50 minimum spend at Specialty Retailer or \$80 at Coles ("Qualifying Spend") at any specialty Torquay Village retailer, in one single transaction.
7. Customers can scan instore the entry QR code which directs to the Torquay Village website ([www.https://torquayvillage.com.au/](https://torquayvillage.com.au/)) and enter their details online or visit the website directly. Customers must upload copy of their receipt for proof of spend to enter.
8. By providing your email, you will be signed up to the Torquay Village mailing list.
9. Receipts must be an official store receipt with the words "TAX INVOICE" clearly stated. A photo or a scanned copy of the receipt must be kept.
